Introduction

The policy statement sets out the Academy's arrangements for managing the access of providers to students at the Academy for the purpose of giving them information about the provider's education or training offer. This complies with the Academy's legal obligations under Section 42B of the Education Act 1997, the Department of Education, July 2021 "Baker Clause" and the Provider Access Legislation, January 2023.

Student entitlement

All students in Year 7-13 are entitled:

- To gain impartial information on technical education qualifications, university qualifications and apprenticeship opportunities, as part of the careers programme which provides information on the full range of education and training options at each transition point.
- To hear from a range of local providers about the opportunities they offer, including higher education, technical education, and apprenticeships, through talks, information sessions and at our annual careers fair in March.
- To understand how to make applications for the full range of academic and technical courses.
- To have at least six encounters throughout Year 7-11 through assemblies, careers week, STEM workshops, visits, and the careers fair.

Schools must offer:

- 2 encounters for pupils during the 'first key phase' (year 8 or 9)
 - All pupils must attend
 - Encounters can take place any time during year 8, and between 1 September and 28 February during year 9
- 2 encounters for pupils during the 'second key phase' (year 10 or 11)
 - All pupils must attend
 - Encounters can take place any time during year 10, and between 1 September and 28 February during year 11
- 2 encounters for pupils during the 'third key phase' (year 12 or 13)
 - Pupils can choose to attend
 - Encounters can take place any time during year 12, and between 1 September and 28 February during year 13

These encounters must happen for a reasonable period of time during the standard school day which runs from 8:30am to 3:20pm. However, Madeley Academy will continue to provide complementary experiences during session 3 (3:30-5:00pm) or during the evening (for example, at our annual Careers Fair), but encounters outside of school hours won't count towards these requirements.

A number of events, integrated into the school careers programme, will offer providers an opportunity to come into school to speak to students and/or their parents/carers. This will support them in sharing knowledge and awareness of career pathways, to learn more about opportunities for education and training, allowing them to make crucial next step career decisions.

Premises and facilities

The Academy will make the Careers Resource Centre or the Conference room available for discussions between the provider and students, as appropriate to the activity. The Academy will also make available AV and other specialist equipment to support provider presentations. This will all be discussed and agreed in advance of the visit with the Careers Leader or a member of the Careers Team.

Providers are welcome to leave a copy of their prospectus or other relevant course literature in the Careers Resource Centre, which is managed by the Academy Careers Team. This resource centre is available to all students throughout the working day.

Destinations

Destinations for Year 11 students 2024:

There are 198 students in Year 11. As of today, their destinations are as follows:

- 48% of students will continue studying at Madeley Academy Sixth Form (96 students)
- 1% of students have gained an apprenticeship (2 students)
- 51% of students in other educational providers (100 students). Please see breakdown below:
 - 79% at local colleges (78 students)
 - 20% at training providers (20 students)
 - 1% at other Sixth Forms (1 students)

No students are classed as NEET

Year 13 Destinations 2024

We were extremely pleased to secure an average grade of B at A Level, Distinction+ at BTEC and exceptionally strong destination data. Students were resilient and made excellent progress from their AS outcomes. This was achieved through teacher interventions and strong career and pastoral support.

There were 105 students in Year 13. As of today, their destinations are as follows:

University 83% (87 students)

- 100% of the 95 students applying to University have gained a place
- 99% were offered their first choice
- 100% were offered their first or second choice places
- No students were in compulsory clearing this year
- 48% of those who applied are going to 'prestigious' universities, including 2 to Cambridge

Employment/Apprenticeships 17% (18 students)

- 72% have obtained apprenticeships that will lead to further qualifications – many of which have already started (13 students)
- 28% have gained employment (5 students)
